They then report on progress at the start of the next meeting.

## Footpath Right of Way

Thank you to all of those who took the trouble to fill in evidence sheets regarding the existence of a public right of way between Berry Gardens and Jacobean Court.

The evidence we have collected contains: -

- Several witness statements from people who have used the footpath continually over the last twenty years
- A map of Burton from 1850 which clearly shows the footpath
- Title deeds on which the right of way is acknowledged
- A Section 53 Footpath Modification Order made by ESBC to alter the route of the footpath

All this evidence has now been sent to the County Council. We eagerly await their comments.

As we come to the end of the first full term of the Parish Council's existence, it is, perhaps, a good time to look back on the last four years to reflect on what we have achieved.

Amongst our achievements are: -

- \* Appointed a lengthsman to keep Winhill clean and tidy
- \* A Neighbourhood Resource Centre which houses Money Spider Credit Union, Umbrella Parent and Toddler Group, Council Link, CAB and many other community services
- \* Grants given out to local organisations such as local churches, St Mark's Scout Group, Ashby Road Tennis Club, local schools' soccer teams
- \* Regular Parish Newsletters and Parish Council website
- \* Contribution to a footpath on Winhill Recreation Ground
- \* Successful opposition to unacceptable planning applications such as the proposed development around the Water Tower
- \* Represented you at P.A.C.T. meetings
- \* Collected evidence to present to the County Council to preserve the right of way on the foot path between Berry Gardens and Jacobean Court

The main feature of our existence has, I believe, been our willingness to work with the Borough and County Councils and other organisations for the benefit of Winhill.

### Where Do We Go From Here?

That really depends on you. As I mentioned in a previous editorial, we have begun the process of consultation in order to produce a Parish Plan.
